- Dancers must turn in the attached Dancer Information Form upon their arrival to auditions. Dancers under the age of 18 must have a parent/guardian signature in order to participate.
- Dancers should come dressed in a professional manner as they will be judged on their presentation.
 - o Hair should be pulled back off of face, preferably in a bun.
 - Female dancers should wear a leotard, tights, and a skirt/shorts.
 Apparel should allow dancer's movements to be clearly viewed by judges.
 - Male dancers should wear a shirt and pants/shorts that are not overly baggy.
 - Dancers should bring ballet or jazz shoes. If trying out "en pointe," please bring pointe shoes as well.
- Auditions will consist of the following skills and combinations:
 - o Right and left splits
 - o Turns (outside turns, fouetté turns)
 - o Leaps
 - o Two ballet combinations
 - o One jazz combination
 - One pointe combination (may be done in ballet shoes)
 - Acting (reading or storytelling)
- Dancers will be judged on the above dance skills, as well as a variety of technical elements including control, timing, knowledge/memory, showmanship, posture, etc.

Results

- Audition results will be posted by Tuesday, April 30 at 5:00PM.

- Based on audition scores, dancers will be placed into one of four levels.
 - Junior Company
 - o Ensemble
 - Soloist
 - o Principle
- Contracts will be mailed to each dancer by June 3, 2019.
- The signed contract, along with the required fee of \$200 (\$100 for Junior Company), must be turned in at the mandatory meeting on June 13.
 If you cannot make full payment on that day, you will be asked to sign a document that includes an agreed upon payment schedule.
